1. Chairperson Lin Gibson began the meeting by providing some opening remarks:

- Lin, Carl and staff person Madison Keegans attended the Latornell Conservation
 Symposium in November. Nels Conroy, past Chair of the Source Protection Committee,
 was recognized at the symposium with a Leadership Award for his environmental work
 in our community.
- Lin and Carl attended the Conservation Ontario council meeting of December 10 where CO passed their own by-law amendments. Kim Gavine, the General Manager presented her report that focused on the state of the relationship between CAs and the new government and that it appears that we will continue to be connected to the MECP and with MNRF for some areas such as natural hazards. Bill 66 was recently introduced by the Provincial Government. It was also discussed briefly at the meeting, gives municipalities the power to bypass existing acts, such as the Clean Water Act and implication for the Provincial Policy Statement and Building Code.
