- 1. Chair Davidson opened the meeting by thanking members for accommodating the rescheduling of the meeting and for attending.
- 2. No declarations of conflict of interest were made.
- 3. Adoption of Agenda/Addition to Agenda

Resolution 2023-40 Kaufman - Fortin

- 4. <u>Previous Meeting Minutes</u>
 - a) Adoption of Minutes of April 12, 2023

Resolution 2023-41 Cormier - Fortin

That the minutes of the April 12, 2023 General Meeting, as circulated and reviewed, are approved.

b) Business arising from the minutes not otherwise addressed

The agreement for the natural heritage inventory at Lake Laurentian CA with Laurentian University / Living with Lakes Centre discussed at the April board meeting has been drafted. The research team met with Carl and the process is moving forward.

5. General Business

a) Flood Season Debrief

Anoop Naik provided an overview of the two flooding events of April and May 2023. He provided an summary of Conservation Sudbury's flooding stations. A quick spring snow melt in April led to very high flows, and then two weeks after high precipitation created a second flooding event.

Anoop and Carl responded to questions from the board with regards to flood mitigation structures. Chair Davidson thanked Anoop for the very informative presentation.

b) <u>Investment Update</u>

Gil Ciulini of RBC Dominion Securities is the chosen investment portfolio manager. He presents annually to the Members to provide an update on the performance of Conservation Sudbury's investments. Gil provided a presentation and answered several questions from the Members.

c) Permissions Under Section 28/29

Resolution 2023-42 Fortin – Leduc

That the report for permits issued under Sections 28 of the Conservation Authorities Act during the month of April 2023 is received.

d) Regulation Review Committee Hearing

Member Kaufman sits on the Regulation Review Committee and spoke briefly about the hearing held the week prior. In instances where a Section 28 permit for

development cannot be issued by staff as the proposal does not adhere to policy, the landowner has the opportunity to appeal at a hearing. The hearing on May 18, 2023 displayed good collaboration between the landowner and staff. The Committee supports the proposal and recommends that a permit is issued.

Resolution 2023-43 Cormier – Labbée

Given that the Regulation Review Committee (RRC) met with the applicant at a public hearing conducted on the Microsoft Teams platform on May 18, 2023 and that the applicant and Authority staff were provided ample opportunity to explain their positions, to ask and respond to a variety of questions, and

Given that the RRC deliberated in-camera based on the information provided to them, and reached a decision that supported the proponent's position at that time, and

Be it resolved, that the application by Alexandra Stempel and Martin Brosseau for permission for an addition to a single family dwelling not exceeding 31% of the structure's cumulative floor area at 59 Larchmont Drive, Township of Dowling, be granted. The proponent shall satisfy all conditions that are typical of additions in floodplains to the satisfaction of staff before permit issuance.

e) Health and Safety Update and Return to Work

Carl spoke about some updates to the COVID-19 safety plan and the enactment of the Return to Work Policy. Employees will required to work in the office setting at least 40% of the time in each pay period as of June 5, 2023.

f) Request for Reserve Allocation, WECI projects

The Province's Water and Erosion Control Infrastructure (WECI) program provides a cost-sharing grant to conservation authorities to maintain and upgrade flood damage reduction infrastructure. For 2023, Conservation Sudbury was successful in receiving funding for four projects and Carl elaborated on each of these.
